123.2. Representations from members of the Public:

123.2.i Quentin Merrit from Conserving Coniston & Crake did a presentation on their work. The organisation are putting together a full application for lottery funding in November and if this is successful work will begin in Feb/March.

123.2.ii. Councillor David Fletcher gave some updates to the council. By the end of March 2017 SLDC will be introducing recycling of plastics and cardboard as well as the current recycling. In the last heavy rains there was flooding in Ulverston and the Duddon Valley, e,ergency cover was supplied by SLDC and over 600 tonnes of household waste was removed as a result of the flooding. Flooding forums are looking at why flooding is occurring and what they can do to help prevent further flooding. Which involves looking at the catchment areas.

The district gulley cleaning contract has been brought back in house by SLDC instead of going out to contract.

The ticket machine on the Windermere Ferry have been implemented to protect staff and have more security for the money taken. The system isn't working as well as it should at the moment and is being looked at.

SLDC are now removing bins from homes which are used as holiday homes as this is classed as commercial waste and should be paid for through business rates rather than council tax.
