PCSO Debbie Ross attended the meeting and gave us a report on the crimes which have occurred in the last 6 weeks. Please find this attached. Debbie will be at Coniston Library Post Office on 18<sup>th</sup> July between 10am – 12pm for anyone who would like to see her.

We invited Neil Morris and David Higgs to come along to the meeting to chat to the council about the work that they do in the community. At the moment there are only 4 First Responders to cover from Ambleside down to Backbarrow and across to Coniston. The have airwaves pagers and they will respond to as many callouts as possible due to their location and work commitments. First Responders do not attend trauma callouts such as road traffic accidents, they deal mainly with heart attacks, strokes, diabetes, and minor incidents where they can get to the casualty fast. They have helped 4 local communities in the area utilise their unused phone boxes to house defibrillators that they have bought with raising the funds through donations and local fundraising activities. They have offer to help Satterthwaite Parish Council do the same thing. The cost of the project will be approx. £2000, this will involve acquiring the phonebox from BT and the purchase and installation of the defibrillator. It will be accessible to anyone who needs to use it by contacting the emergency services to obtain the access code.
